COMPLAINT

I, THE UNDERSIGNED, SAY, ON INFORMATION AND BELIEF, THAT IN THE COUNTY OF MARIN, STATE OF CALIFORNIA:

COUNT 001: On or about June 01, 1972, to July 01, 1972, the crime of UNLAWFUL ORAL COPULATION, in violation of Section 288a of the Penal Code, a felony, was committed by GREGORY INGELS, who, at the time and place last aforesaid, did willfully and unlawfully participate in an act of oral copulation with John Doe, a child under the age of 16 years.

Prosecution of the charged crimes is commenced pursuant to Penal Code Section 903, subdivision (g).



THE DISTRICT ATTORNEY FURTHER ALLEGES that on August 27, 2002, John Doe reported to a law enforcement agency that he, while under the age of eighteen (18) years, was the victim of a sexual crime as specified in Penal Code Section 803, subdivision (g). The limitation period specified in Section 800 and/or 801 has expired as to that crime. In addition, the crime involved substantial sexual conduct, to wit: oral copulation, and there is independent evidence that clearly and convincingly corroborates the victim's allegation, to wit: During a tape recorded conversation with John Doe, in relation to the act of oral copulation, defendant made numerous incriminating statements, to wit: "what I did to you was terrible," and "the point is, I did this to you," and "it was an authority issue." He further stated that he was sorry and ashamed of what happened, and offered to provide John Doe with the services of a psychologist.

I DECLARE UNDER PENALTY OF PERJURY THAT THE FOREGOING IS TRUE AND CORRECT EXCEPT AS TO THOSE MATTERS STATED ON THE INFORMATION AND BELIEF AND AS TO THOSE MATTERS I BELIEVE THEM TO BE TRUE.
