NOTICE UNDER SEAL OF INTENT TO RELY ON INSANITY DEFENSE

COMES NOW the Defendant, LISA MARIE NOWAK, by and through the undersigned, pursuant to Fla.R.Crim.P. 3.216(b), and files notice of intent to rely at trial on insanity defense.
