Pretrial Intervention Program
DEFERRED PROSECUTION AGREEMENT

It is being alleged in Information #06CF005460A02, that you, RUSH HUDSON LIMBAUGH, committed an offense against the State of Florida, to-wit: WITHHOLDING INFORMATION FROM A PRACTITIONER and it further appearing that after an investigation of the offense and into your background, the interest of the State of Florida, and your interest, will best be served by entering into this agreement:


Therefore, Barry Krischer, State Attorney, in and for the Fifteenth Judicial Circuit, Palm Beach County, Florida, agrees that prosecution in this matter for said offense will be deferred for a period of 18 months from this date, provided you abide by the following conditions:

1. You will refrain from violation of any law.
2. You will pay to the State of Florida thirty (\$30.00) dollars per month towards cost of your supervision unless exempted in compliance with Florida Statutes.
3. You will work regularly at a lawful occupation and support any dependents to the best of your ability.
4. You will not change your residence or employment without first notifying your Pretrial Intervention (PTI) officer.
5. You will make yourself available for the services of the Pretrial Program by reporting by mail to your PTI Officer as directed.
6. You acknowledge that your employer must be informed of your status in the program within thirty (30) days of your acceptance or within thirty (30) days of employment, should you obtain a new position after acceptance.
7. You will neither possess nor carry any firearm or weapon.
8. You will truthfully answer all inquiries by your Pretrial Intervention Officer and comply with all instructions he or she may give you.
9. You will not use intoxicants to excess, nor will you visit places where intoxicants, drugs or other dangerous substances are unlawfully sold, dispensed or used.


10. You will submit to a urinalysis, breathalyzer, or blood tests at any time requested by your Pretrial Intervention Officer. Compliance with this request may be made through your treating physician and the results submitted by mail. Should you test positive for a controlled substance, you may be required to receive a Drug Evaluation and treatment, if recommended.
11. Special Conditions:
 - a. You will continue ongoing substance abuse treatment with DR. STEVEN STRUMWASSER until such time that DR. STEVEN STRUMWASSER determines treatment is no longer necessary.
 - b. You will submit to random urinalysis testing as directed by your Pretrial Intervention Officer. Manner of compliance as indicated in Paragraph 10.
 - c. You will reimburse law enforcement for costs of investigation; specifically Boca Raton Police Department, Boynton Beach Police Department, Jupiter Island Department of Public Safety, Lantana Police Department, Palm Beach Police Department, Palm Beach County Sheriff's Office, West Palm Beach Police Department, by tendering within 90 days a check made payable to Office of the State Attorney, Money Laundering Task Force in the amount of \$30,000.
12. The State Attorney may, during the period of Deferred Prosecution, revoke or modify the conditions of your Deferred Prosecution by:
 1. Changing the period of Deferred Prosecution.
 2. Prosecuting you for this offense if you violate any of these conditions.
 3. Voiding this agreement should it be determined that you have a prior record of adult criminal felony convictions.


If you comply with these conditions during the period of Deferred Prosecution, no criminal prosecution concerning this charge will be instituted for the offense for which you are placed on the program or if already instituted, the charged will be nolle prossed.


Signing this Deferred Prosecution Agreement withdraws and/or waives your rights to a speedy trial under the Constitution and laws of Florida, and the United States of America in the cause of which prosecution is being deferred.


